**IF THE COURT DATE IS ON A WEEKDAY,** Call the Victim Witness Program at the DA’s office to find out location and time of the bond hearing. The DA’s office is open from 8am-5pm Mon-Fri.

**IF THE COURT DATE IS ON A WEEKEND,** the Judge will still need to hear from you about the protection order and bond. To do this, you need to contact a victim advocate 970-350-9600 ext 4. You do not have to attend the bond hearing, it will be at the Weld County Jail. For updates on your case status you must contact the district attorney’s office, victim witness program at 970-356-4010.

**IF THE ARREST IS MADE ON THE DAY BEFORE A COURT HOLIDAY,** the bond arraignment will be held at the North Jail at 2110 “O” Street, Greeley. Please call the Weld County North Jail, Booking Department at (970) 356-4015 Ext. 3915 to determine the date and time of the bond hearing.

The Constitution of the State of Colorado and the laws of this state guarantee rights to the victims of the following crimes:

- **Murder**
- **Manslaughter**
- **Criminally Negligent Homicide**
- **Vehicular Homicide and Vehicular Assault**
- **Assault**
- **Menacing**
- **Kidnapping**
- **Sexual Assault and Unlawful Sexual Contact**
- **Incest and Aggravated Incest**
- **Child Abuse**
- **Sexual exploitation of children**
- **Child Prostitution**
- **Crimes against at-risk adults and at-risk juveniles**
- **Indecent exposure**
- **Violation of a criminal protection order issued against a person charged with sexual assault, stalking, domestic violence, or crimes against at risk person**
- **Robbery—aggravated, aggravated of a controlled substance**
- **Crimes for which the underlying foundation has been determined to be domestic violence**
- **Careless driving that results in the death of another person**
- **Failure to stop at the scene of an accident that results in the death of another person or serious bodily injury**
- **Stalking**
- **Human Trafficking**
- **First degree burglary or second degree burglary of a dwelling**
- **Invasion of privacy**
- **Bias motivated crimes**
- **Retaliation against a victim, witness, judge , juror, prosecutor, or elected official**
- **Tampering with a victim or witness**
- **Intimidation and aggravated intimidation of a victim or witness**
- **Posting a private image for harassment or pecuniary gain**
- **Criminal invasion of Privacy**
- **First degree arson**
- **Any criminal attempt, conspiracy, criminal solicitation, or accessory involving any of the crimes specified above**

If a victim is deceased or incapacitated, these rights may be exercised by the victim’s spouse, parent, legal guardian, child, sibling, grandparent, grandchild, significant other, or other lawful representative.

The Greeley Police Victim Assistance Unit can provide information and referral to the **Colorado Address Confidentiality Program**. This program provides victims of domestic violence, sexual offenses or stalking with a means to prevent abusers and potential abusers from locating them through public records. **(24-21-201 C.R.S.)**

**Victims of the crimes specified within the Victim Rights Act have the right to:**

- Be treated with fairness, respect and dignity;
- To be present at specified critical stages in the criminal justice process;
- Information on all charges filed;
- Notification of any change in the status of the accused;
- Input into decisions regarding plea bargains, dismissals or other dispositions, sentencing and parole hearings;
- Restitution or civil remedy;
- Timely notification of all court dates;
- To be kept informed as to whether a suspect has been taken into custody, and if known, whether the suspect has been released from custody, any bond conditions imposed upon the susupect, and informed if the suspect has escaped, been released, transferred or if the suspect has expired;
- To prevent any party at any court proceeding from compe-lling testimony regarding a victims address, telephone number, place of employment, or other locating informa-tion;
- Release of property after the case is settled and it is no longer needed as evidence;
- Notification of all case dispositions or appeals;
- Instruction on community resources and other information that will assist recovery;
- To be provided with appropriate employer intercession services regarding court appearances and meetings with criminal justice officials;
- After conviction of a crime, upon written request from the victim; state or local correctional authorities will notify the victim of critical stages;
- To be informed of the existence of the criminal protection order and upon request of the victim, the procedure for modifying the protection order if a procedure exists;
- To have the victim’s social security number redacted or excluded from criminal justice documents when records are released to someone other than the victim, a criminal justi-ce agency, or the defendant’s attorney of record.

**As a victim of one of the crimes specified in the Victim Rights Act you may be entitled to the following services:**

- **Immediate crisis intervention and follow-up support**
- **Special services for juvenile, elderly or disabled vic-tims**
- **Referral to public and private individuals and orga-nizations providing**
- **Medical and other emergency services**
- **Mental health and social services**
- **Financial assistance**
- **Translation services**
- **Intervention with creditors, landlords and employers**
- **Legal resources**
- **Rehabilitative services**
- **Transportation and child care services**
- **Information about obtaining public records, inclu-ding police reports**
- **Information about protective orders**
- **Other support services**

**Critical Stages**

The following are Critical Stages in the criminal justice process and are designated in the Crime Victim Rights Act. Some of these events may not happen in your case.

- **Decisions to file or not file charges**
- **Preliminary Hearing**
- **Bond Reduction or Modification of Bond Arraign-ment**
- **Motions Hearing**
- **Disposition**
- **Trial**
- **Sentencing or Modification of Sentence**
- **Appellate Review**
- **Post Conviction DNA Testing**
- **Sentence Reconsideration**
- **Probation Revocation**
- **Attack of Judgment**
- **Subpoenas for victim’s records (medical, mental, education or victim compensation)**

Victims have the right to be informed of all the critical stages.  
A victim also has the right to be heard at a hearing on bond reduction, acceptance of a negotiated plea, senten-cing, and modification of sentence.

**Victims of crime have the following responsibilities:**

- **Keep appropriate criminal justice authorities infor-med of their or their representative’s name, address, email address, and telephone number, and any chan-ges in this information**
- **To request that the correctional officials keep their address, telephone, place of employment and other personal information confidential.**

**Colorado VINE is a proactive notification system that sends you an automatic alert anytime an offender’s custody status changes.**

Colorado VINE information is available to you 24 hours a day, seven days a week, 365 days a year. You will be notified about the release, transfer, escape or death of an offender by phone, email, text and/or TTY.

*Remember, while Colorado VINE is meant to protect you, don’t rely solely on Colorado VINE for your safety. If you feel you might be at risk, take precautions as if the offender has already been released.*

***AVAILABILITY OF PUBLIC RECORDS***

Victims may request a free copy of the initial report at the Greeley/Weld Criminal Justice Records, from the respective Police Agency. 8:00 a.m. to 4:00 p.m. Monday - Friday.

Release of records are at the discretion of law enforcement and/or the District Attorney.

***VICTIM COMPENSATION***

If you or a member of your family has been injured as a result of a crime you may be eligible for compensation for financial loss.

- **The Victim Compensation Board may award for:**
- **Medical and hospital expenses**
- **Loss of medically necessary devices, such as eyeglasses or hearing aids**
- **Counseling**
- **Burial expenses**
- **Loss of earnings**
- **Loss of support to dependents**
- **Repair of residential doors, windows or other security devices.**

This fund consists of money provided through fees levied against persons convicted of felonies, misdemeanors and certain traffic offenses. **WHAT CAN I EXPECT?**

The initial shock following a crime, sudden death, or other trauma is a harsh and painful reality for everyone involved. As individuals we often react in many different ways when faced with crisis. Some common reactions may include:

- **Shock, disbelief, numbness**
- **Anxiety, panicky feelings**
- **Feeling “lost” or difficulty concentrating**
- **Irritability, tearfulness, or anger**
- **Blaming, self-doubt, guilt**
- **Sleeping disturbances, loss of appetite**
- **Flashbacks, unwanted memories**
- **Depression or sadness**
- **Withdrawal or isolation**
- **Relationship problems**
- **Unexplained physical pain**

***PROTECTION FOR CRIME VICTIMS***

The legal process can be confusing and difficult if you are seeking help in the courts, especially if you are doing this on your own. Temporary protection orders may be obtained by contacting the Combined Court Clerk’s Office located in the Centennial Center 915 10th St., **(970) 475-2400 or [www.courts.state.co.us](http://www.courts.state.co.us)**. Assistance may be requested by calling **GPD Victim Assistance (970) 351- 5345**. A protection order produ-ced by a private attorney is always an additional opti-on. **Modification of criminal Protective Orders are done by Filing a modification request with the court clerks office and informing the DA’s Victim witness unit.**
